Suggestions:

It is best to download the FREE Zoom app first. Click on the link and wait for the host to let you into the meeting. If the link above or on your Zoom invitation does not open, right click on it with your mouse and select the Open Hyperlink option. If that doesn't work, open your Zoom app on your phone or computer, select Go to Meeting, then when prompted, enter the Meeting ID – no password is required. **You will see a message to test your audio while you wait for the host to let you into the meeting, and adjust the mics**. If your audio is not working for some reason, you can continue to use your video and call in on the phone to communicate. If your internet connection is slow, you might try participating without your video on, and your name will come up instead of your image.

If you prefer, you can also just dial one of the two numbers above, and enter the Meeting ID. No password is required. It will seem like a regular conference call and is quite easy to do. Try to log into the meeting a few minutes early so that Patti can respond to your call before the meeting begins.
